

... connecting citizens to improve governance

- To learn about a place, go to the market
- Market as source of information and news
- Organized chaos exchange of ideas, dealing and building consensus







... connecting citizens to improve governance

The Law of the Two Feet



- Use you two feet
- Responsibility for learning and successful outcome reside in you
- Make a difference by moving to a new place and interacting with new people
- Remember: Learning comes only by applying and sharing knowledge

The Four Paths



- Whoever comes is the right person
- Whatever happens is the only thing that could have
- Whenever it starts is the right time
- Whenever it's over it's over

Transparency

- Decision-making and enforcement follow set rules and regulations
- Information is freely available for those who will be affected by decisions
- Information is adequate, relevant, easily understandable

Accountability

- Those in power should be answerable to those who will be affected by their decisions or actions
- They should also be responsive to the needs of citizens from whom their power is derived





... connecting citizens to improve governance





Participation

- Involvement of citizens in decision-making and in efforts to improve their conditions
- Citizens should have freedom to associate, capacitate themselves, and express their interests and views



Participatory planning:


Naga City People's Council

- Empowerment ordinance of 1995 which institutionalized NCPC
- Vote and participate in deliberations on design, implementation and evaluation of projects and programs
- Outputs: Naga City River Watershed Plan, Naga City Waste Management Plan, City Health Development Plan

Social accountability tools

Budget monitoring:

NGO Forum in Cambodia

- Performed monitoring and analysis of the national budget from 2004 to 2006
- Key findings: Share of budget items for "pro-poor" programs and services have decreased; national budget is not aligned with development plan; limited information on actual spending by ministries
- Outputs: Established working relations with government officials, promoted awareness of national budget process

Social accountability tools



Participatory expenditure tracking:

Concerned Citizens of Abra for Good Governance (CCAGG)

- CCAGG works out a plan with the concerned government agency to monitor spending on and implementation of infrastructure project
- CCAGG organizes monitoring teams from the beneficiaries of proposed project and trains them in field-based monitoring work
- Organization unearthed several anomalies in implementation of infrastructure projects

Social accountability tools



Participatory performance monitoring:

Citizen report card - Bandung Institute of Governance Studies (BIGS), Indonesia

- Conducted surveys, seminars, focused group discussions with urban poor to measure effectiveness and genderresponsiveness of government's housing policy. BIGS also documented slum conditions by taking photos and videos of these areas.
- Key findings/results: Local government's budget and housing policy did not effectively address urban poor problem; networking with local government and other stakeholders to address urban poor problem.

For constructive engagement and effective citizen monitoring under social accountability to happen ...

We need to have the 4 pillars of an enabling environment:

Government openness

Organized and capable citizens

Access to information

Cultural appropriateness







Six Thinking Hats

Evaluating Innovative Ideas and Analyzing Proposals



This proposal analysis tool invented by Edward de Bono is particularly useful for evaluating innovative and provocative ideas.

As participants wear each hat — white, red, yellow, black, green, or blue — they all must think a certain way at the same time.

Key benefits:

- encourages Parallel Thinking
- encourages full-spectrum thinking
- separates ego from performance
