GOAL

OPEN DOORS 2012 aims to contribute to the regional procurement agenda of ANSA-EAP and its partners by sustaining the connection and dynamic exchange among the country groups involved in the procurement monitoring sub-network.

SPECIFIC OBJECTIVES

OPEN DOORS 2012 gives life to the strategy of ANSA-EAP to provide the networking, capacity building, and technical support necessary for the emergence of capable SAc practitioners that could eventually evolve into a resource group for sustained and quality procurement work. Its objectives are:

1. To present updates from network partners about the tales, tools, and techniques (3Ts) in citizen monitoring, specifically on procurement and other Public Finance Management (PFM) processes (e.g. advocacy work and gains in countries where procurement law and mechanisms are still being advocated);
2. To present the experience of the procurement scorecard pilot as a tool to advance SAc in procurement monitoring in EAP countries; and
3. To strengthen a procurement monitoring network on two levels—a country network at the first level, and a regional network at the second level—for purposes of facilitating knowledge sharing and strengthening tools, strategies, and approaches.
